## WELCOME TO MARAVILLA 1205

We hope you have a pleasant and relaxing stay at our home. Our condominium is decorated and furnished to provide for your vacation needs.

- **ARRIVAL:** Our home is carefully inspected following each departure. If upon your arrival, you find any irregularities or damage, please contact us immediately to insure that your damage deposit is not withheld upon your departure
- **SAND:** The Guest is responsible for leaving sand at the beach. If excess sand is in the condo, you will be charged an additional \$50 for sand removal. Sand damages floor, showers and furniture
- **AIR CONDITIONING:** Do not operate the air conditioner with any doors or windows open as this will cause the A/C unit to freeze and malfunction
- **DAMAGE DEPOSIT:** Refundable within two weeks of departure, provided the rental agreement provisions are met, which are:
  - Number of occupants not to exceed 8 guests
  - No smoking in unit
  - No pets in unit
  - Check in/out according to times arranged
  - No damage to building, furniture or appliances
  - No towels, linens or any other items to be taken from the condo. Please bring your own towels for the pool and beach use
  - Abide by the posted association rules, which are also mailed to guests
  - If Improper Behavior occurs, damage deposit will be forfeited
  - Perform Departure Day Checklist
- **BUNK BEDS:** The third bedroom contains one bunk bed. Between guests, the bed is inspected while cleaning the condo. The guests are responsible for verifying the good working order of the bed. The guests are solely responsible for any property damage or physical injury that may result from negligent use of the bed
- **DEPARTURE DAY CHECKLIST**
  - Remove all grocery items and garbage to outside dumpster
  - Hand wash pots and pans. Dry and put away. As you leave, run dishwasher on all other dirty dishes
  - Leave appliances clean and straighten condo
  - Do not wash linens or towels
  - Turn off lights and fans. Close and lock the doors
  - Place keys back into the lock box
  - Check out time is 10:00 a.m.
- **CANCELLATIONS:** Daily and weekly reservations that are cancelled more than 60 days prior to the arrival date will incur a \$50 processing fee. Cancellations or changes that result in a shortened stay, which are made less than 60 days prior to the arrival date, will cause forfeit of all money collected.

- **HURRICANE POLICY:** No refunds will be given unless:
  - The National Weather Service orders mandatory evacuations in a “Tropical Storm/Hurricane Warning area”, of which Maravilla is included, and/or
  - The day the National Weather Service orders a mandatory evacuation order in a “Tropical Storm/Hurricane Warning area”, we will refund:
    - Any unused portion of rent from a current guest
    - Any unused portion of rent from a guest that is scheduled to arrive after a Hurricane Warning is lifted and therefore wants to shorten their stay
    - Any advance rents collected or deposited for a reservation that is scheduled to arrive during a “Hurricane Warning” period
  
- **MINIMUM AGE REQUIREMENT:** The guest that signs this rental agreement must be at least 25 years old and must stay in the condo each night. If it is determined that nobody over 25 years old is in the condo each night, the Damage Deposit will be forfeited and the guests will be immediately evicted
  
- **IMPROPER BEHAVIOR:** Guests are to conduct themselves in a manner inoffensive to the neighbors. Guests and visitors agree that any improper activities on the property, including disturbances, annoyances, or inconveniences of the neighbors, use of the premises for immoral or unlawful purposes, or violations of any law or ordinance will immediately terminate occupancy and this Agreement
  
- **LIABILITY LIMITATIONS:** Paul and Anita Schnapp shall not be liable to Guest, his guests, licenses or invitees or any other person for any injury, loss or damage to any person or property on or about the premises. Guest shall hold Paul and Anita Schnapp harmless and indemnified from and against all loss, injury or damage occasioned by the use or misuse or abuse of any part of the premises, parking lot, beach, ocean or community, and from or against any omission, neglect, or default of Guest, his guests, licensees or invitees
  
- **ASSIGNMENT:** This Rental Agreement may not be assigned or the Condo sublet and is for the Guest’s use only
  
- **MISCELLANEOUS:** No charges to, or changing of locks of the Condo are permitted. Guests will not use premises as location for amateur or professional film/video
